This mare is booked specifically by name. The booking is valid to the mare named and may not be transferred without the consent of Fox Den Farm.

Fox Den Farm reserves the right to reject any mare deemed physically unfit. No blind or chronically lame mare will be accepted. Approved booking agreements must be on file before the mare can be bred. No mare will be bred for patrons with overdue accounts. All charges including transportation, veterinary fees, board, breeding, etc., shall be paid monthly by the owner of the mare or foal as per terms month. The service fee is normally due and payable when the mare has a live foal (a live foal is one that can stand and nurse), or changes ownership, whichever occurs first. In the event that the mare is sold, the fee if unpaid, shall immediately become due and payable and no refund shall be due from Fox Den Farm unless such refund is guaranteed by Fox Den Farm in writing prior to the mare's sale. At its option, Fox Den Farm may require that the service fee be paid before the mare is removed from the farm. Should legal assistance be required in order to collect a service fee or a board bill, the legal charges incurred by Fox Den Farm will be borne by the client.

Fox Den Farm is authorized without liability and at its discretion, to engage veterinary service, trim feet, deworm, vaccinate, administer feed supplements, or do any other work on any mare or foal deemed by Fox Den Farm as a contributory to said animal's general or reproductive health, or appearance, with charges for such service to be billed monthly.

Neither Fox Den Farm, nor its members, agents or employees shall be liable for any injury or disability or death suffered by any horse from any cause whatsoever, while in the custody of Fox Den Farm and the owner/agent specifically assents to such condition, and waives all and every claim for damages resulting from injury or disability as a condition for boarding and breeding horses at Fox Den Farm. Fox Den Farm will be glad to assist any client in obtaining insurance on any animal in Fox Den Farm's custody. This relates to broodmares, foals and yearlings being maintained at Fox Den Farm.

## **Boarding Terms & Conditions**

This agreement covers any or all horse(s) entrusted to the care of Fox Den Farm by the undersigned Owner or Representative.

Board will be charged at a daily rate in accordance with Fox Den Farm's published yearly rate schedule. In addition, veterinarian and other fees such as, but not necessarily limited to: hoof trims, X-rays, injections, worming, palpitation. Ultrasound, etc. shall be at the owner's expense.

Fox Den Farm will exercise due diligence in caring for all horses in its care. Fox Den will perform the customary practices for the protection, health and safety of all animals in its care. However; Fox Den Farm, its Manager and/or employees cannot assume any liability for illness, accidental injury, disability or death suffered by any animal in its care. The undersigned owner consents to waive all and every claim for damage resulting from illness, injury or death.

Any charges incurred while the horse is in residence at Fox Den, MUST be paid prior to the release of the horse. Overdue accounts will be charged a late charge of 1.5 percent per month. Failure to pay any amounts due Fox Den in a timely manner pursuant to this agreement shall additionally result in the payment by the undersigned of reasonable attorney fees, and other charges incurred by Fox Den Farm in connection with the collection thereof to the fullest extent permitted by applicable law.
